## **President's Column**

The purpose of the Massachusetts Genealogical Council newsletter is to spread the word about the activities and goals of the Council. We want you to share this newsletter with anyone who may be interested: genealogists, researchers, historians, librarians, archivists. We want society leaders to forward it to their members, make copies and post them on bulletin boards in places where genealogists and historians meet. Maintaining and expanding access to records is our goal. Our mission can be summed up in three words:

#### ACCESS EDUCATION

**PRESERVATION** 

- Access: We work to ensure that researchers are able to access the records that they need. We do this by monitoring legislation, both state and federal, that affects our right to view and copy records. Unfortunately, the right of individuals to see records is under constant threat.
- Education: Education has two aspects. We hold day-long seminars to give genealogists and historians opportunities to discover new record sources and to learn better methods for analyzing and using that information in their research. We work actively with members of the legislature to inform them of our interests. We are also making renewed efforts to expand and consolidate our relationship with the records custodians. Those are the people who hold the data of concern to us: archivists, city and town clerks, librarians, and officers and staff of historical societies and museums.
- **Preservation:** We are working with organizations such as Familysearch and Findmypast to identify records of interest to us and

try to expand the records that are available online. We want to identify and develop inventories of material in archives that are of importance to our supporters. We know there are records that are under threat of destruction due to poor storage conditions and lack of space. We read of significant loss of local historical materials in other states. We do not want it to happen in Massachusetts.

Help our efforts by spreading the word of our activities and providing a donation of time and/or financial support to the Council. WE NEED YOU!





## MBTA Commuter Rail outbound from Boston on the Worcester Line

on both Saturday and Sunday

Train leaves South Station at 6:40am and makes all station stops between Boston and Westborough. Train arrives Westborough Station at 7:50am. We will make arrangements for transportation between Westborough Station and the Marriott Hotel. We will need notice that you are using this option. We will be sending out an email to all registrants closer to the conference so that you can tell us if you are using this route. Be aware that Saturday trains commonly only open the car at the front of the train for passengers.

On the return trip, train leaves Southborough at 4:55pm and arrives at Boston at 6:00pm. Again we will arrange transportation to the station.

## Metrowest Regional Transit Authority provides local bus service between their hub in Framingham (near the Commuter Rail Station) and Marlborough (www.mwrta.com)

The Marlborough service is on Route 7. The stop would be Route 20 and Felton Street. Service on Saturday is less frequent than on weekdays so this is not as convenient as the Commuter Rail. However, if you anticipate coming out on Friday and spending the night, it is a good option.

## **MGC Is Following Two Federal Bills**

## With the focus on presidential primaries recently, we've detected no action on either of the bills we are following.

S 1073	"A Bill to amend the Improper Payments Elimination and Recovery Improvement Act of 2012, including making changes to the Do Not Pay initiative, for improved detection, prevention, and recovery of improper payments to deceased individuals, and for other purposes."	No action since the Senate Committee on Homeland Security read the bill, added amendments, and passed it back to the full Senate with a favorable recommendation in July 2015.
HR 2003	"A Bill to amend the Improper Payments Elimination and Recovery Improvement Act of 2012, including making changes to the Do Not Pay initiative, for improved detection, prevention, and recovery of improper payments to deceased individuals, and for other purposes."	This bill remains in the House Ways and Means, and the House Oversight Committees where it has been with no action since April 2015.



## MASSACHUSETTS LEGISLATIVE NEWS

## Public Records Law

MGC is closely monitoring the progress of legislation designed to change Massachusetts' public records law that is considered by many to be among the weakest in the country. Many groups, including the Massachusetts ACLU, the Massachusetts Freedom of Information Alliance, Common Cause Massachusetts, and the Massachusetts Newspaper Publishers Association, are working to reform the law allowing greater and easier access to public records in Massachusetts.

Currently, the House has passed H3858, An Act to improve public records. The proposed legislation was significantly changed as it made its way through the House in response to complaints by municipalities that they would be burdened by the terms of the previously proposed legislation. The Senate will be voting on their version of the bill, S2120, An Act improving the administration and enforcement of the public records law, on Thursday, February 4. It is expected to pass which will then require the two branches to meet in conference to iron out the differences in the two bills.

Both bills require that state agencies and municipalities designate a records access officer and that records be provided in electronic format whenever possible. The bills also limit the fees charged for hard copies and the preparation of materials. Unfortunately, both bills retain the current exemption for the legislature, the judiciary, and the governor's office.

So what are the significant differences between the two bills? The Senate requires attorneys' fees be awarded to successful challengers of a denial whereas the House version leaves it up to the judge to award such fees. The Senate also imposes punitive damages up to \$5,000 for noncompliance. The House timetable requires responses to requests be made within 10 business days but allows the response process to take up to 60 days for state agencies and 75 days for municipalities. The Senate requires compliance within 15 days, up to 30 days if more complex, and provides a 30-day extension of good cause is shown.

## MGC Asks Your Support for Legislation

MGC has put forth three pieces of legislation currently stalled in committees and supports a bill put forth by the Secretary of State. H2820 would eliminate the restriction on records of those born out of wedlock; restricts exemption of personnel and medical files to only those of living persons; and would remove the restriction on public inspection of records after 75 years. This legislation is stalled in the Joint Committee on State Administration and Regulatory Oversight. MGC's legislation, S1069 and S1629 would do much the same as H2820 (although S1629 would only open records older than 90 years) but are currently stalled in the Joint Committee on Municipalities and Regional Government and the Joint Committee on State Administration and Regulatory Oversight, respectively. Our bill, S1630, would provide for a non-certified copy of records for genealogical purposes thereby lowering the cost of historical research and is currently before the Joint Committee on State Administration and Regulatory Oversight. We urge Massachusetts' citizens to check if their representative or senator are on these committee and then contact them to urge their support of H2820 and S1630.

## MASSACHUSETTS LEGISLATIVE MONITORING STATUS

## **Bills the MGC supports:**

\*\*S1629 – An Act relative to records open to public inspection – Opens all records, 90 years or older, in the custody of the state secretary. Sponsored by Kenneth J. Donnelly (by request). Currently before the Joint Committee on State Administration and Regulatory Oversight.

\*\*S1630 – An Act to lower the cost of creating record copies for historical researchers – Provides a noncertified copy for genealogical purposes. Sponsored by Kenneth J. Donnelly (by request). Currently before the Joint Committee on State Administration and Regulatory Oversight.

\*\*S1069 – An Act to end the stigmatization of out-of-wedlock births – Eliminates restricted access to out of wedlock birth records. Sponsored by Kenneth J. Donnelly. Currently before the Joint Committee on Municipalities and Regional Government.

*H2821 – An Act relating to creation of a municipal records commission* – Establishes a special commission to examine the status, maintenance, preservation, and storage of municipal records in the Commonwealth with support and advice from the Massachusetts Archives. Sponsored by Angelo M. Scaccia. Currently before the Joint Committee on State Administration and Regulatory Oversight.

*H2822 – An Act relating to the public records law* – Provides authority to the Secretary of the Commonwealth, supervisor of records, or any officer designated by the Secretary to investigate violations or enforce the public records laws. Sponsored by Angelo M. Scaccia. *Currently before the Joint Committee on State Administration and Regulatory Oversight.* 

*H3858 – An Act to improve public records –* Regulates the access to public records by designating a records access official, outlining procedures to fulfill requests, and imposes penalties for failure to fulfill requests. (Previously H3665 which had previously incorporated H2772 and S1676.) *Currently approved by the House. The Senate is considering their own legislation.* 

**S2120** – **An Act improving the administration and enforcement of the public records law** – Regulates the access to public records by designation a records access officer, outlining procedures to fulfill requests, and imposes penalties for failure to fulfill requests. *Has been placed on the Orders of the Day for 4 February 2016 for a vote.* 

*S1144 – An Act relative to equal access to original birth certificates –* Eliminates the date restriction on adoptees obtaining birth information. Sponsored by James B. Eldridge. *Currently before the Joint Committee on Public Health.* 

*S1633 – An Act improving access to public records –* Provides for the designation of records access officers by each State agency and provide access to public records. Sponsored by James B. Eldridge. *Currently before the Joint Committee on State Administration and Regulatory Oversight.* 

*S1700 – An Act relative to obtaining information* – Provides that custodians of public records comply within 10 days and the process for pursuing claims for failure to do so. Sponsored by Kathleen O'Connor Ives. *Currently before the Joint Committee on State Administration and Regulatory Oversight.*

## Massachusetts Legislative Monitoring Status (Con't):

#### **Bills the MGC are simply monitoring:**

\*\*H2820 – An Act relating to technical corrections – Removes entities receiving or expending funds for state pensions from the definition of public records. Eliminates the restriction on records of those born out of wedlock. Also restricts exemption of personnel and medical files to only those of living persons. *Caveat*: Restricts public inspection of records to "after the expiration of seventy-five years from creation of the record." Sponsored by Angelo M. Scaccia. *Currently before the Joint Committee on State Administration and Regulatory Oversight*.

*H1051 – An Act relative to preserving Polish heritage in the Pioneer Valley* – Establishes a commission to investigate the establishment of a heritage institute at University of Massachusetts at Amherst. Sponsored by Peter V. Kocot. *Currently before the Joint Committee on Higher Education*.

*H1265 – An Act relative to public records requests –* Increases the fines on public officials for failure to perform their duties with respect to public records from \$20 per month to \$100 per month. Sponsored by Diana DiZoglio. *Currently before the Joint Committee on the Judiciary.* 

*H1962 – An Act relative to the vital records trust fund* – Apportions money received from the payment for certified copies issued by town or city clerks and establishes the Secure Vital Registry Trust Fund to be expended by the department of public health. Sponsored by Denise C. Garlick. *Currently before the Joint Committee on Public Health.* 

*H2034 – An Act preserving date of birth from city and town records* – restricts date of birth for individuals in city or town public records to only the year of birth. Sponsored by Elizabeth A. Poirier. *Currently before the Joint Committee on Public Health.* 

*H2045 – An Act granting equal access to original birth certificates to all persons born in Massachusetts –* Removes the date restrictions for adopted children to obtain original birth information. Sponsored by John H. Rogers and Michael F. Rush. *Currently before the Joint Committee on Public Health*.

*H2716 – An Act further regulating access to public records* – Establishes a public records division within the office of the secretary of the commonwealth and a commission of public records.

Sponsored by Antonio F. D. Cabral. Currently before the Joint Committee on State Administration and Regulatory Oversight.

*H2717 – An Act to improve access to public records* – Regulates electronic recordkeeping systems and that every state agency has a records access officer to respond to requests for access to public records. Sponsored by Antonio F. D. Cabral. *Currently before the Joint Committee on State Administration and Regulatory Oversight.* 

*H2755 – An Act relative to public record fines* – Provides a time limit for public records custodians to comply with requests and increase fines of such officials to \$100 per month. Sponsored by Bradford R. Hill. *Currently before the Joint Committee on State Administration and Regulatory Oversight.* 

*H2794 – An Act relative to restricted vital records* – Removes restrictions on out of wedlock birth returns but leaves in place certain other restrictions. Sponsored by Michael J. Moran. *Currently before the Joint Committee on State Administration and Regulatory Oversight.* 

*H2807 – An Act to maintain the integrity of the public records law* – Expands the application of the public records law to non-profit corporations formed by political subdivisions. Sponsored by Angelo J. Puppolo, Jr. *Currently before the Joint Committee on State Administration and Regulatory Oversight.*

## Massachusetts Legislative Monitoring Status (Con't):

#### **Bills the MGC are simply monitoring (Con't):**

*H3862 – An Act relative to modernizing the Registries of Deeds* – Requires the keeping of an entry book of registered land, in book or electronic form, by an assistant recorder. Appears to be uninteresting but Norfolk County Registrar of Deeds testified in favor of the bill which he believes would allow him to digitize deeds and then destroy the originals! (Previously H1493). Sponsored by the Joint Committee on the Judiciary. *Currently before the House Committee on Ways and Means*.

*S1641 – An act amending public records law --* A minor technical restriction. Sponsored by Ryan C. Fattman. *Currently before the Joint Committee on State Administration and Regulatory Oversight.* 

*S1638 – An Act enhancing access to electronic public records* – Regulates electronic recordkeeping systems and enhances access to public information contained therein. Sponsored by James B. Eldridge. *Currently before the Joint Committee on State Administration and Regulatory Oversight.* 

#### **Bills the MGC will oppose:**

*H1942 – An Act to protect personal information* – Expands current restrictions on out of wedlock, etc. births to all birth records such that a person can only seek his own record (or their attorney, guardian, parent). The provision would not apply to records before 1 January 1841. Sponsored by Kimberly N. Ferguson. *Currently before the Joint Committee on Public Health.* 

*H2036 – An Act relative to access to certain birth records –* Limits access to records and returns of children born out of wedlock only where the infant was given up for adoption or the name of the father is not listed. Sponsored by Elizabeth A. Poirier. *Currently before the Joint Committee on Public Health.*

## Spotlight on Supporting Organizations The Irish Ancestral Research Association - TIARA By Susan Steele

**TIARA** (The Irish Ancestral Research Association) established in 1983 as a non-profit organization, promotes the growth, study and exchange of ideas among people and organizations interested in Irish genealogical and historical research and education.

TIARA's monthly meetings encourage this exchange of ideas. Ten yearly meetings feature a diverse group of speakers. These meetings are usually held at the Mandel Center for the Humanities, Brandeis University in Waltham, MA. All are welcome to attend.

TIARA issues a quarterly newsletter featuring research strategies, member stories and articles of Irish and general genealogical interest. TIARA's website includes information on TIARA activities, member projects and a surname database. A library at TIARA's Aurburndale office includes unique Irish interest books and CDs.

TIARA leads research trips in both the US and Ireland. Trips to Dublin and Belfast take place on an annual or biennial basis. Research assistance is provided before and during trips. Domestic trips have included Salt Lake City and New York City.

TIARA has joined The Irish Genealogical Society International (IGSI) in planning a second Celtic Connections Conference. This year's conference entitled "Celtic Roots Across America" will bring together those interested in all aspects of Celtic culture, through genealogy, history, music and literature. The two-day event will include 20+ lecturers and presentations by well-known experts and will be held in Minneapolis, Minnesota, on August 5-6, 2016. TIARA members have been involved in numerous preservation efforts including several cemetery transcription databases and the Foresters Project. Founded in 1879, to provide life insurance benefits for its members. The Massachusetts Catholic Order of Foresters accumulated thousands of records that included personal data, family information, physical examinations and beneficiary designations. Over a six-year period, volunteers indexed 27,000 records before transferring ownership of these records to UMass Boston. TIARA volunteers continue to work with the Archives and Special Collections, Healey Library, UMass Boston in ongoing indexing of these See http://blogs.umb.edu/archives/ records. collections/foresters/ for a more completed description of the Foresters Project. TIARA members have also joined another UMass Boston volunteer effort - The Boston Police Strike Project. The goal of the 1919 BP Strike Project is to document and preserve the stories of the more than 1,100 police officers who were involved in this highly influential labor strike.

## Spotlight on a Brand New Genealogy Lineage Society Group Descendants of Cape Cod and the Islands - DCCI

Descendants of Cape Cod and the Islands (DCCI) came about through a discussion on 17 May 2015 between Shari Kelley Worrell, Heather Welty Speas and Kimberly Ormsby Nagy, MD, with regards to the possible reorganization of the hereditary society, Sons and Daughters of Nantucket. Within a week of that discussion, a new lineage group had emerged with a founding Board in place.

It was decided to expand the ancestral area to encompass all of Cape Cod along with Nantucket, Martha's Vineyard and Elizabeth Islands. Karen Avery Miller suggested the new inclusive name of the society.

The new society quickly established eligibility, purpose and objectives, bylaws and articles of incorporation, an application form, brochure and other necessary forms.

The society was officially organized in the state of Illinois on 10 June 2015. Since then, 115 members from 34 states and 3 countries have been approved and continues to grow. In addition, key advisors were also appointed by the President General, Shari Kelley Worrell. The society's newsletter, *The Lighthouse*, was created, and premiered September 2015.

The society will hold its first annual meeting the weekend of October 28-30, 2016 in historic Sandwich at The Dan'l Webster Inn.

The first project of the society was the decision to offer for sale note cards and poster prints of Cape Cod Lighthouses by Bev (Mueller) Schreiber (1948-2014). The preservation fund for the Highland Light (oldest and tallest lighthouse on Cape Cod), located in North Truro, MA, was selected as the recipient of proceeds from the sale of these items. DCCI made its first donation of \$250 on 17 November 2015.

## Purpose

The Society is organized exclusively for charitable, and educational purposes under section 501(c)(3)of the Internal Revenue Code, or corresponding section of any future federal tax code.

## Membership Eligibility

Membership is extended to men and women 18 years of age or older who are direct lineal descendants of an ancestor who was a resident, owned land, conducted a business or trade, or performed military or civil services prior to 31 December 1699, within the boundaries of present-day Cape Cod, Elizabeth Islands, Martha's Vineyard or Nantucket.

The following is a partial list of acceptable activities for eligibility:

- Ancestor resided and/or owned land in what is now Cape Cod, Elizabeth Islands, Martha's Vineyard or Nantucket.
- Ancestor engaged in trade or commerce in what is now Cape Cod, Elizabeth Islands, Martha's Vineyard or Nantucket.

• Ancestor established a trading post in what is now Cape Cod, Elizabeth Islands, Martha's Vineyard or Nantucket.

• Ancestor engaged in some of the initial surveying and exploring activities in what is now Cape Cod, Elizabeth Islands, Martha's Vineyard or Nantucket.

• Ancestor served as a court judge hearing cases pertaining to what is now Cape Cod, Elizabeth Islands, Martha's Vineyard or Nantucket.
